**"C.C.SHETHH COLLEGE OF COMMERCE"** situated in Ahmedabad at Ashram road, Navgujarat Campus, opp. Gujarat Vidhyapith, Ahmedabad, Gujarat - 380014, represented by Dr. Dharmendra S. Mistry here in after referred to as **"CCSCC"** which expression shall unless it be repugnant or contrary to the meaning thereof shall mean and include its successors-in-title and assigns of the Other Part;

##### Whereas

- DATRI is a non- profit organization with a mission of saving the lives of those suffering from life threatening blood disorders like Blood Cancer, Thalassemia, and Aplastic Anemia etc. DATRI is working towards creating a wide and diverse database of potential blood stem cell donors that can be accessed by any patient, living anywhere in the world, in need of a blood stem cell transplant.
- CC Shethh College of Commerce is a degree college and works as a part of Navgujarat Group of Colleges managed by Vidya Bhavan Trust. It aims at creating a peaceful and congenial educational atmosphere so that the students undergo comprehensive development and are capable of influencing the society with honesty, tolerance and integrity. It is located in a big campus of more than 5,500 sq. meters in area and houses nearly 30 class rooms. Originally known as Navgujarat Vanijya Mahavidyalaya, it was founded in 1968 and got its present name in 1995.
- DATRI and CCSCC have considered it necessary to enter into this MOU to record their initial understanding.

Now this MoU witnessed as follows: -

- This Agreement will be effective from 24<sup>th</sup> day of June 2024.

2. The parties consider this MoU to be a document recording their initial intentions and understanding on the efforts to further the mission of the respective organizations.
3. CCSCC agrees and confirm their interest in partnering DATRI in their various initiatives / drives for creating awareness in the mission of DATRI and be allowed to register donors for their registry purposes.
4. CCSCC informs that the donor registrations shall be free of cost and no monies to be collected by DATRI for the registration. However, if any of the donor is willing to donate money, it has no objection in DATRI receiving the monies as donations. DATRI confirms it has all governmental approvals to receive such monies as donation.
5. CCSCC agrees that it shall ensure all arrangements are done for conducting the event in its premises and in case of outdoors, sufficient space and furniture required for DATRI activities for the events.
6. CCSCC shall provide the space and other infrastructure at the event for DATRI's activities to collect samples.
7. CCSCC agrees that it shall allow its volunteers for collecting the samples from Donors as and required for the event.
8. DATRI shall detail a session explaining the registration procedure to become a blood stem cell donor with the Registry to all the participants and benefits of the stem cell donation.
9. DATRI shall collect the details in appropriate forms and sample only from those who willingly come forward to register with them. Once the forms are duly filled and eligibility is ascertained, the sample (buccal swab) shall be taken from them.
10. DATRI agrees that all the details collected from the donors who register with them shall be treated as confidential and the details shall be used only for the purpose mentioned therein and shall not be used for any personal or commercial use. The information shall not be shared with any other party including the other parties to the agreement.
11. DATRI confirms that it shall provide an online registration link in joint names. Both parties agree the data collected shall be under possession of DATRI and shall not be shared with any other party and shall be used only for the purpose to have a registration link
12. CCSCC agrees that no costs shall be collected from DATRI for the arrangement and all costs for conducting the event shall be borne by them.



13. DATRI confirms that any Donor who is registering can get in touch with DATRI (contact number shall be shared with all donors) at the address abovementioned in case of any requirement pertaining to the registration.
14. The Agreement shall remain in effect for one year. During the tenure of the agreement, any changes in the location, Authorised signatory, Management in the respective parties shall be communicated to the other parties / signatories to the addresses / email ids as mentioned The Agreement.
15. This Agreement may be terminated, without cause, by either party upon giving one calendar month's written notice, which will be delivered by hand or by electronic / certified mail to the address listed above.
16. This Agreement between DATRI, CCSCC supersedes all prior negotiations, representations and agreements, whether written or oral.
